Oratory Competition Rules

10th – 12th Grades

1. During the registration process, an I.D. number will be assigned to each participant.
2. Students will deliver a speech for a minimum of 2 ½ to a maximum of 4 minutes in a controlled environment.
3. The speech must be related to the English Week theme.
4. Teacher should screen the speech and help his/her student.
5. The student should give a short introduction of him or herself. This would not count as the speech time. Time begins when student mentions title of his/her oratory speech.
- 6. Student cannot use index cards or paper as a guide, to read speech.**
7. The student must provide three (3) copies of the selected rhyme, which are to be given to the judges before the beginning of the recitation. The judges will provide a value of one (1) point will be given to this criterion.
8. The student will be judged using an oratory rubric.
9. The student will perform in front of an audience.
10. Three judges will be appointed. One judge will keep time, all three judges will evaluate according to oratory rubric.
11. Coordinator will be consulted for decision making and communication in the case of any situation in the competition.
- 12. Students must wear their school uniform throughout regional and central level competitions.**
